Enterprise Fire Department

Deputy Chief Mulderig reported that they had 30 calls in May.

David Turner - Director Community Development, Tourism, & Planning

David updated the board with the latest numbers for the WWTP upgrade.

Mayor and Trustee Comments

Mayor Borchik said as you know we've been notified of the NY Forward Grant approved projects. 11 projects have been funded and the recipients will be notified in the next one to three months. Mayor said an individual that wants to remain anonymous would like to donate a life size statue of Cathy Lee for Henley Park. Trustee Maxam said they had a meeting for the Bridge House Brats and it was very productive.

Trustee Hartner said there will be a planning board meeting on Thursday, June 6th at the Fire Department to review and approve site plan and application along with a major subdivision for the Walts development project located at St. Rt. 264.

Department Comments

Chief Nerber said that Memorial Day went great. Officer Doody continues to investigate the incident to the police boat. The police department received a grant for \$18,088 for enforcement technology and equipment. Administrator Lynch said that he and the DPW have begun conducting interviews for a laborer position. Lynch advised the board that we should form a committee to discuss the WWTP expansion and how we are going to pay for it. Phoenix Rising has made a donation along with an individual for a new concession stand at the Bridge House, we've made a decision that we'll revamp a shed that was not used for the basketball/volleyball court. Lynch updated the board regarding the triplex residential unit on Elm and Bridge Street, they have all their stamped drawings in, it's been reviewed by himself and the engineer, also the DPW has walked the site for water/curb stops and sewer connection points, the owner will be receiving his permit in the next few days and the project will start soon.
