Mayor Borchik began the Board Meeting with Pledge of Allegiance at 7:00

KL Consulting – Kristy LaManche

Kristy spoke to the board about the Consolidated Funding Application (CFA) opened up Monday, May 13th, in the past we've gotten funding for Community Development Block Grant, sewer and water, parks funding, NYS Main St, Strategic Planning and Comprehensive Plan, in the days and weeks ahead if you have any project ideas please let the Mayor or Jim know. There is a grant workshop coming up on June 18th at 6:00pm to have members of the community come and hear about different opportunities for funding and see if that will generate some project ideas for future applications. Applications are due July 31st.

Kristy reported that The Restore NY application has a few items that we are required to submit. Kristy prepared the draft resolution and also SEQR short form EAF parts I, II and III, she's initiated SHPO and they have received it and have accepted our submission, we still need to hear back from them. She has also reached out to the planning board chair and have received back a letter stating that the existing and proposed uses of the building are consistent with zoning so we shouldn't need anything further.

Motion to approve municipal resolution relative to SEQRA review and approving application for grant funding from Empire State Development's Restore NY communities imitative municipal grant program round 8 was made by Trustee McBurnie, seconded by Trustee Maxam, Trustee Hartner aye, Trustee Koegel aye, Mayor Borchik aye. Motion carried.

David Turner – Director Community Development, Tourism, & Planning

Dave asked the board to consider an application to EFC that's due June 14th, a resolution that is named The Plan of Finance. We have new opportunities that gets us about 10% more in the grant application, there's currently a \$154,000 gap, Oswego County IDA agreed to put in half of that with the contingency that the Village matches that and that EFC fully fund that project.

Motion to approve resolution outlining a plan of finance for the Phoenix/Schroeppel wastewater treatment & conveyance project and authorizing Mayor Brian Borchik to act on behalf of The Village of Phoenix, New York as the authorized representative and authorizing David Turner, Director of Strategic Initiatives for the County of Oswego, as the daily contact in an application for funding assistance through the NYS Environmental Facilities Corporation was made by Trustee McBurnie,

seconded by Trustee Maxam, Trustee Hartner aye, Trustee Koegel aye, Mayor Borchik aye. Motion carried.

Motion to approve the resolution to enter into an intermunicipal agreement with the County of Oswego, the Town of Schroeppel and the County of Oswego IDA for constructing, funding, of the WWTP Project was made by Trustee McBurnie, seconded by Trustee Maxam, Trustee Koegel, Trustee Hartner aye, Mayor Borchik aye. Motion carried.

Motion to approve resolution granting Mayor Brian Borchik the Authority to Sign A Certificate of Occupancy at the direction of the Town of Lysander Codes Officer/Building Inspector for a Property Located at 15 Culvert Street, Phoenix, New York was made by Trustee McBurnie, seconded by Trustee Koegel, Trustee Hartner aye, Trustee Maxam aye, Mayor Borchik aye. Motion carried.

Mayor and Trustee Comments

Mayor Borchik updated the board on the Bridge House Brats and Henley Park, we've received a lot of donations, hanging baskets, a lot of flowers, our DPW has done a lot of work down at the park and everything looks really nice. Megan currently has over 30 brats signed up and is expecting more to come in, with the volunteers we have already she believes all the schedules are covered but if anyone wants to volunteer to please let him know.

Trustee McBurnie reported that this weekend is the Field Days at the VFW with the parade on Monday, and hopes to see everyone there.
