The Volney Street crosswalk we spoke about a few weeks ago, he didn't realize it would take 18-24 months for the NYS DOT to do their analysis whether they think it's appropriate or not. They said they'd try to fast track it and get the permit started and perform a site survey. The DOT would be responsible for signage, painting and lighting, and the Village would be responsible for the sidewalk on both side along with handicap pads. There was also a discussion on crossing guards.

Lynch will be drafting a letter for the Foster Well land and the owners that have access to it.
